WHO'S WHO IN COFFEE

Dr. Oswaldo Aranha, Newly Appointed Ambas-sador of Brazil to the United States, Is Given Welcome Dinner on Arrival at New York

DR. OSWALDO ARANHA, the newly appointed Ambassador of Brazil to the United States, arrived in New York on the Rex, from Italy, on September 13th. In the evening, he was given a dinner of welcome by the Brazilian Committee of the Pan American Society at the Waldorf-Astoria. The dinner was attended by prominent members of the coffee trade, including officers of the Associated Coffee Industries of America. It is planned to give a formal dinner to Dr. Aranha in New York later on when all the members of the trade have returned from holidays.

Following the reception, Dr. Aranha proceeded to Washington, where he assumed the duties of his

new post.

Dr. Aranha is acknowledged as Brazil's leading authority on her coffee problems and his firm policy as Minister of Finance was responsible for the orientation of the National Coffee Department. It is expected that his appointment as Ambassador to the United States will result in the development of enlarged Brazilian-American co-operative commercial intercourse.

BIOGRAPHICAL

The new Brazilian Ambassador was born in Alegrete, State of Rio Grande do Sul, February 15, 1894. He attended the Military College in Rio de Janeiro and then the School of Law of the University of Rio de Janeiro, where he received his degree in 1916. He then returned to his native State to practice law, and started his political career upon being elected Mayor of Alegrete. Later he was chosen Representative to the House of the State of Rio Grande do Sul and then Representative from that State to the Federal Chamber of Deputies.

He resigned his post as Representative in 1928 to become Secretary of Interior of the State of Rio Grande do Sul under President Vargas. When President Vargas assumed the Federal Government, Dr. Aranha was appointed Minister of Justice [Attorney General] and, two years later, Finance Minister, the post which he has relinquished to become Ambassador at Washington.

TEA CESS CHAIRMAN IN THE U. S.

Mr. J. A. Milligan, chairman of the India Tea Cess Committee, Calcutta, is due to arrive in America on the "Carinthia," September 17th. Mr. Milligan's visit is to be an extended one as he plans to make a comprehensive tour of the United States. This is Mr. Mililgan's first visit to America.
